The Faculty of Food Technology and Merchandizing of the Saratov State Agrarian University named after N.I. Vavilov, Russia, and the Research Institute of Food Science and Technology, Mashhad, Iran, in view of mutual interest entered into the following agreement:

FOR COLLABORATION IN RESEARCH, EDUCATION AND TRAINING PROGRAMS

(THE TECHNOLOGICAL AND MERCHINDIZING FACULTY)

AND

THE RESEARCH INSTITUTE OF FOOD SCIENCE AND TECHNOLOGY (RIFST), IRAN

The Faculty of Food Technology and Merchandizing of the Saratov State Agrarian University named after N.I. Vavilov, and the Research Institute of Food Science and Technology agree to exchange staff members. The costs (travel, lodging, allowances) will be met by the sending institution or grants gained by the staff members involved in the exchange.

The agreement may be altered by mutual written consent at the request of either the Faculty of Food Technology and Merchandizing of the Saratov State Agrarian University named after N.I. Vavilov or the Research Institute of Food Science and Technology.

AGREEMENT FOR COLLABORATION

Both parties agree in a direct cooperation between the Faculty of Food Technology and Merchandizing of the Saratov State Agrarian University named after N.I. Vavilov, Russia, and the Research Institute of Food Science and Technology, Mashhad, Iran, in fields of mutual interest as stated in the following articles.

Article 1

The Faculty of Food Technology and Merchandizing of the Saratov State Agrarian University named after N.I. Vavilov, and the Research Institute of Food Science and Technology declare their intention to consolidate their cooperation in research activity and other common interests.

Article 2

Both parties will be encouraged to continue or start cooperation involving the following activities: exchange of staff members, participation in research activities and joint publication in scientific papers.

Article 3

Both institutions encourage common applications for research grants, joining research consortia and joining international scientific networks.

Article 4

The Dean of the Faculty of Food Technology and Merchandizing of SSAU and the head of the Research Institute of Food Science and Technology, will manage the cooperation between the parties.

Article 5

The Faculty of Food Technology and Merchandizing of the Saratov State Agrarian University named after N.I. Vavilov, and the Research Institute of Food Science and Technology, agree to exchange staff members. The costs (travel, lodging, allowance) will be met by the sending institution or grants gained by the staff members involved in the exchange.

Article 6

This agreement may be altered by mutual written consent at the request of either the Faculty of Food Technology and Merchandizing of the Saratov State Agrarian University named after N.I. Vavilov or the Research Institute of Food Science and Technology.

Any alterations shall become effective at the same time that both parties indicate their consent.

Article 7

Two copies of the present Agreement in English and in Russian have been signed; one copy is retained by the parties.

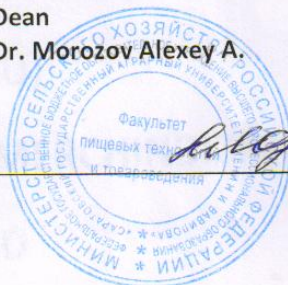
